AUTHORIZING RESOLUTION BOARD OF COMMISSIONERS TOWN OF BUNN, NORTH CAROLINA

Supplemental Grants Program

WHEREAS, The 1998 Critical Needs Bond Act has authorized the making of loans and grants to aid eligible units of government in financing the cost of construction of wastewater treatment works, wastewater collection systems, and water supply systems, water conservation projects; and

THAT Jerry W. Kennett, Mayor, and successors so titled, is hereby authorized to execute and file an application on behalf of the Town of Bunn with the NCREDC (Rural Center) for a grant to assist in the construction of the project described above.

THAT Jerry W. Kennett, Mayor, and successors so titled, is hereby authorized and directed to furnish such information as the Rural Center may request in connection with such application for the project; to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

THAT The Town of Bunn has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to the grants pertaining thereto.
