

Ordinance 25-08

An Ordinance establishing an Annual Fee Schedule for various fees charged by the Town of Bunn.

The Town Commissioners of the Town of Bunn, North Carolina ordains: The following Annual Fee Schedule is established for all fees charged by the Town and eliminating the need for specific listing of fees in the zoning ordinance and subdivision regulations including other fees related to utilities and other Town services.

Sewer Taps – Estimate Only plus 5% Administrative fee

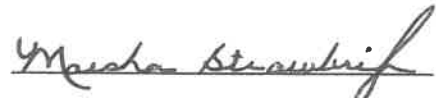
* Town supplied meters are the contractor's responsibility for any damage to meters during construction
